### Resolution No. 2018-03

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TUKWILA POOL METROPOLITAN PARK DISTRICT LEVYING FROM THE GENERAL TAXES FOR THE FISCAL YEAR, COMMENCING JANUARY 1<sup>ST</sup>, 2019, ON ALL PROPERTY BOTH REAL AND PERSONAL, IN COMPLIANCE WITH RCW 84.55.120.**

**WHEREAS**, the Tukwila Pool Metropolitan Park District has properly given notice of a public revenue source hearing held on Nov. 12, 2018, pursuant with 84.55.120; and

**WHEREAS**, the Board of Commissioners of the Tukwila Pool Metropolitan Park District has considered the District's anticipated financial requirements for 2019 and the amounts necessary and available to be raised by ad valorem taxes on real and personal property; and


**WHEREAS**, the final assessed valuation calculation has been determined;


**NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE TUKWILA POOL METROPOLITAN PARK DISTRICT HEREBY RESOLVES AS FOLLOWS:**

There shall be and hereby is levied on all regular and personal property in the Tukwila Pool Metropolitan Park District, in King County, whose estimated assessed valuation is \$6,723,890,452, current taxes for the ensuing year commencing January 1<sup>st</sup>, 2019 in the amount of \$1,050,000 including \$2,163 in refunds.
