In consideration of participation in Tukwila Pool Metropolitan Park District programming or use of the equipment/facility, I, _____, the undersigned participant and parent/guardian, **AGREE TO INDEMNIFY AND HOLD HARMLESS** Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to participation.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation of Tukwila Pool Metropolitan Park District programs or use of the facility/equipment and that I voluntarily, for myself and Minor(s) voluntarily assume said risks.
